• **BUILDING PERMIT:**

Must be obtained from Construction Code Authority..... (810) 667-0420  
(A Zoning Permit is required from Oregon Township before a building permit will be issued by Construction Code Authority...See Zoning Permit below)

• **BURN PERMIT:**

Residents in the Lapeer City Fire Department area, contact Lapeer City Fire Department at 810-664-0833 or online at Lapeer City Fire District Burn Permit.....**No charge**  
Residents in the Marathon Area Fire Authority area, contact Marathon Area Fire Authority at 810-793-2002 or marathontwp.com.....**No charge**  
*If you are unsure of the Fire Department that services your area, please call*

**Violations are:**

- \*Fires outside of an enclosed burner without first obtaining a burn permit.
- \*Fires outside of an enclosed burner where sufficient precautionary measures have not been taken to prevent the fire from burning out of control.
- \*A person who burns any materials, which are prohibited by state statute from being burned in the open.
- \*Any person who has an alarm system on their premises and does not maintain the

System so that false alarms are not transmitted to the fire department.

➤ **Penalties for illegal burns:**

First Violation.....	\$ 250.00
Second Violation.....	\$ 500.00
Any Violation Thereafter .....	\$1,000.00
Any person who turns in a malicious false fire alarm.....	\$1,000.00

➤ **Non-property owners:**

- Car fires, personal properties, false alarms, wash down after auto accidents, rescue, Jaws of Life or any other response which does not cause a fire.....\$ 500.00
- Downed Wire (all public utilities) per hour ..... \$ 500.00

➤ **Real property owners:** (exempt from paying property taxes and not opting into the Special Assessment and paying fees for each identified parcel on the tax roll.)

- Structure Fire.....\$2,500.00
- Duty Officer (CO alarm, etc.).....\$ 400.00
- Car fires, personal properties, false alarms, wash down after auto accidents, rescue, Jaws of Life or any other response which does not cause a fire.....\$ 500.00
